### Trail Difficulty Guide

- ☺ **EASY** — Mostly flat trails/roads with gradual hills, no side hills, some water crossings less than 10 inches in depth, and possible mud depending on season.
- ☐ **INTERMEDIATE** — Some side hills, loose rocks, water crossings between 10 to 16 inches in depth, possible muddy and ruddy trails/roads, and occasional steep hills, and possible some snow and/or ice depending on the season.
- ♦ **DIFFICULT** — Possible rocky or deep ruddy trails/roads and steep side hills, potential water crossings with depth over 16 inches, very slow travel and possible deep snow and/or ice depending on the season.
- ☺ **COMBINATION** — Combination of difficulties or variety of terrain (Intermediate to Difficult).
- ? **UNKNOWN** — No information at publishing time.

*Note: The conditions of the trails or roads are subject to time of year and weather.*

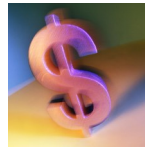

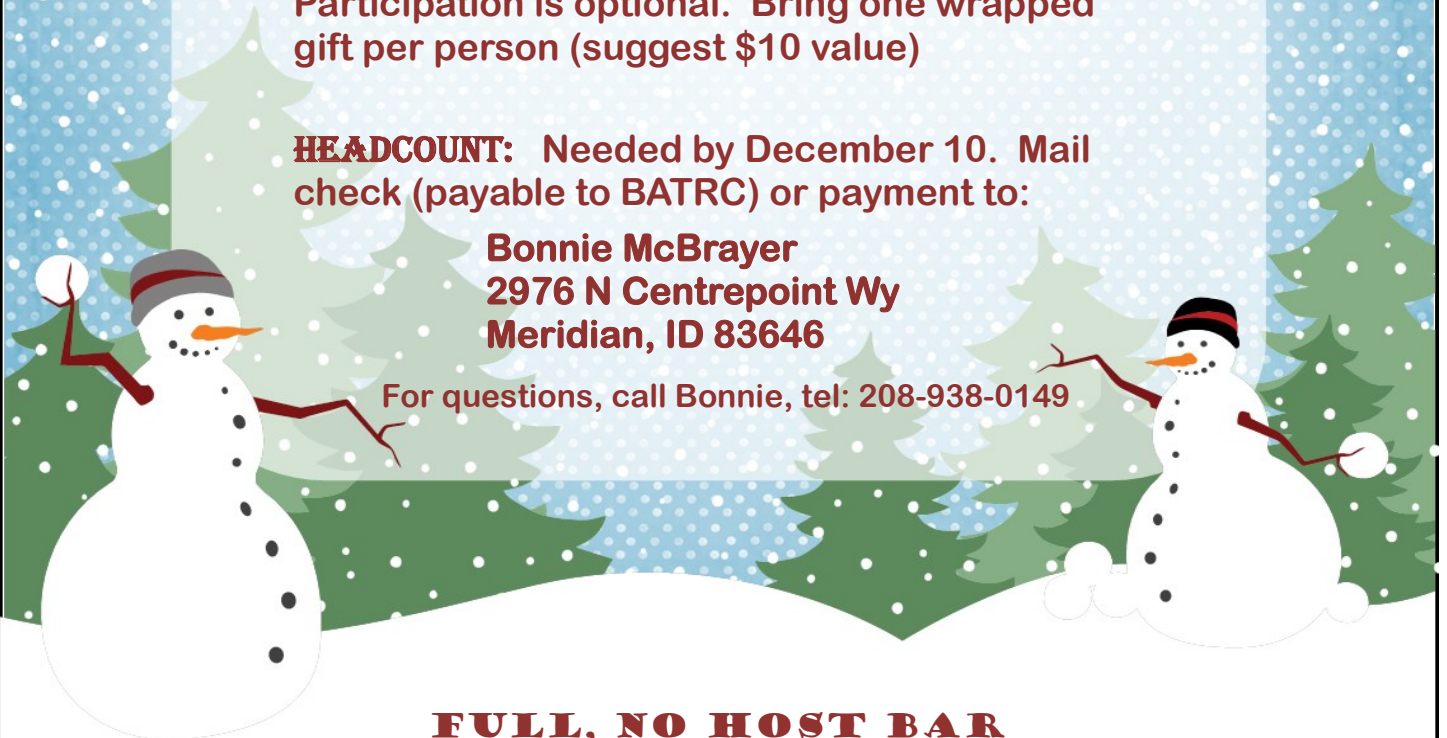

## *D.C. Actions and Idaho Recreation by Adena Cook*



Two bills making their way through Congress could have a huge impact on Idahoans' outdoors activities, writes Adena Cook. Two bills, both important for Idaho recreation, are now nearing final stages in Congress.

The first, S1813, passed the Senate Environment and Public Works Committee. It contains the Recreational Trails Program (RTP), which has provided \$1.7

million annually for Idaho trails. Formerly a part of the federal gas tax, the RTP is now in S1813, which generally addresses highways and transportation.

The RTP is included along with transportation enhancements, and safe routes to schools. Funding for S1813 will be considered separately, and may be difficult.

The link that the original highways bill established between the federal gas tax and that small gas tax portion used by OHVs on trails has been generally lost.

A similar bill is moving through the House, but it is wrapped within a broader energy and infrastructure jobs bill. There could be controversial amendments attached to this bill, such as allowing oil and gas leases in the Arctic National Wildlife Refuge.

Idaho Sen. Mike Crapo has been doing a great job for Idaho keeping RTP at least in the picture. Idaho trails will continue to need his help. RTP's path to passage and funding is far from clear.

The second bill, the Department of the Interior Appropriations Act, is a multi-faceted funding bill sponsored by our representative, Mike Simpson. When it passes the House, it may have some controversial riders attached, such as a ban on national monument designation without congressional approval.

A companion Interior Appropriations Act in the Senate has not passed. There is, however, a chairman's mark bill. I understand that, through some procedural sleight of hand, this bill will likely be used by the Senate to reconcile with the one that passes the House. I also understand that this Senate bill contains, as a rider, Sen. Jon Tester's (D-MT) Forest Jobs and Recreation Act, a disingenuous title if there ever was one.

Tester's bill designates new acres of wilderness in Montana, including the south half of Mount Jefferson, the crown jewel of western snowmobiling, and linchpin of Island Park's and Fremont County's tourist economy. The bill has been heard in the Senate Energy and Natural Resources committee, where Sen. Jim Risch, R-Idaho, valiantly defended Jefferson access. It did not pass out of Committee. Still, I understand, it has been included as a rider in the Senate chairman's mark of the Interior Appropriations. Go figure!

As the two bills are reconciled, it will be up to Simpson to keep the stealth rider that locks up Mount Jefferson out of the final bill. He has always been a staunch defender of Jefferson and a strong advocate for Fremont County's economy. I have faith that he can meet this challenge, and he deserves our thanks.
