

**BOISE ATV TRAIL RIDERS
REGULAR MEETING MINUTES
November 18, 2014**

A meeting of the Boise ATV Trail Riders General Membership was held at Idaho Pizza Company at 405 E. Fairview Ave., Meridian, Idaho, on Tuesday, November 18, 2014, at 7:00 p.m. with Steve Huffman, President, presiding and Blake Burgess acting as Secretary.

Steve Huffman, President, called the meeting to order. The President welcomed and introduced new members and guests.

Steve Huffman introduced David Claiborne, the Club's representative to the Idaho State ATV Association ("ISATV") and current President of the ISATV. David indicated that the IRC and ISATV are working on legislation in which ATVs and UTVs would be allowed on state highways. They are also working on a UTV sales tax exemption to non-residents. Currently, the law exempts ATVs, but not UTVs. The ISATV annual meeting will be held August 7-9 in McCall, along with the IRC annual meeting.

Blake Burgess, Secretary, was absent from the November 18 meeting. No minutes were taken in his absence.

Dennis Colton, Treasurer, presented the Treasurer's Report for the month of October 2014, indicating an ending cash balance of \$2,166. It was moved and seconded to accept the Treasurer's Report as presented. The motion passed unanimously.

Mike and Yvette Pierce, Membership Directors, indicated that the Club has approximately 136 memberships of which 114 are paying memberships. Mike indicated the Club store has several BATR shirts, hats and other items available or that can be ordered.

Jim Maxey reviewed past and upcoming rides. The upcoming rides, along with the trail difficulty guide, were presented along with the agenda.
