President's Message

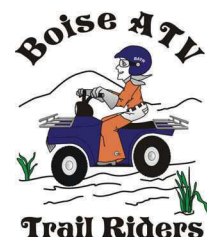
It has almost definitely just about slightly stopped raining for the season. For sure summer is on the way and our members are just itching to get out there and kick up some dust! It is time to think ahead for the summer riding season. This means making sure your ATV is in tip top condition and ready for the great times ahead of us. We need to make sure we have given our machines a good tune up which involves adjusting the valves, putting in a new spark plug, installing a new air filter or cleaning your air filter, checking your tires for proper tire air pressure, checking your battery, checking your engine oil for the proper level, checking the tightness of your wheel lug nuts, and all the other mechanical things that are necessary for your machine to operate flawlessly. There is nothing more disappointing or embarrassing than to have your ATV crap out on you in the middle of a ride with all your friends standing around trying to give you assistance or complaining about your riding talents! Tuning up an ATV can be a pain in the rear. One of my pet peeves is the way the manufacturers cover everything up with plastic and make it so hard to access the entrails of your machine. If you

don't feel comfortable in doing this maintenance yourself, then take it to one of our sponsors for a tune up. It is cheaper to have them do it, than to try it yourself and make things worse! Tuning up your ATV is not all that is needed to have a great summer of riding. Make sure all of your supplies are packed away in your ATV bags. Now is a good time to go through your first aid kit. Remove old medical supplies and replenish them with new. If you're like me you keep some heavy narcotics in your medical kit for times when you break a collar bone, leg, arm, etc. Discard them if they are outdated and get some new stuff from your doctor. It isn't much fun trying to ride out 35 miles on the trail after you break a body part. Narcotics help you out just like power steering. This may also be a great time to take an ATV training course if you are new to the art of ATVing or even if you're an old pup like me and just need a refresher course! Make sure you replace your helmet if it has taken an impact at anytime. Helmets are only good for one good smack. Although you can't see any physical damage, impacts cause internal damage to the components of the helmet! Don't forget to replace the

batteries in your radio and GPS units. If you don't have a radio or GPS you might want to consider purchasing one. I know you would never get lost, but they come in handy when your buddies stray away from their intended route. Garmin makes a nice Rino unit that has a radio & GPS both together in one hand held device. They are pretty sweet, but kind of spendy. (Father's Day is just around the corner, Guys!) I am sure you could find a lot of other things to make your summer safer and trouble free. These are just some of the more important things I had on my mind. I wish you luck getting your ATV squared away for a fantastic summer of riding. Sea Biscuit and I look forward to seeing you out on the trails for our club rides, maintenance projects and clean ups.

Trail Difficulty Guide

- ☉ **EASY** — Mostly flat trails/roads with gradual hills, no side hills, some water crossings less than 10 inches in depth, and possible mud depending on season.
- ☐ **INTERMEDIATE** — Some side hills, loose rocks, water crossings between 10 to 16 inches in depth, possible muddy and ruddy trails/roads, and occasional steep hills, and possible some snow and/or ice depending on the season.
- ◆ **DIFFICULT** — Possible rocky or deep ruddy trails/roads and steep side hills, potential water crossings with depth over 16 inches, very slow travel and possible deep snow and/or ice depending on the season.
- ☉ **COMBINATION** — Combination of difficulties or variety of terrain (Intermediate to Difficult).
- ? **NOT KNOWN** — No information at publishing time.

Note: The conditions of the trails or roads are subject to time of year and weather.

BOSSKI TRAILERS FOR TRAILS PROGRAM

BATVTR, Bosski and Snake River Yamaha Team Up to Improve Area Trails !!!

In the fall of 2009 the Boise ATV Trail Riders Association teamed up with Snake River Yamaha and Bosski, Inc. under a grant through Bosski to procure an ATV maintenance wagon for our club. Under this program, Keith Evans of Bosski, Inc. and Mike Goff of Snake River Yamaha chipped in to get us an ATV wagon at a reduced rate for our trail maintenance work in southwestern Idaho. We settled in on the dual axel 1600 AL model. Although we obtained the maintenance wagon last fall, we didn't have an opportunity to use it until May 15, 2010. This was our first major trail maintenance program of the season in the Danskin area east of Boise. We used the Bosski wagon as a support utility wagon

for our maintenance outing in assisting the US Forest service. We stocked the wagon with four garden rakes, a cooler full of ice water, two pair of loppers, a box of trash bags, a lunch box and a few packs of medical supplies. We could easily fit this into the trailer and we still had tons of room for more equipment. The trailer has a hinged rack that can be lifted up to stow supplies inside the weatherproof compartment. Once the rack is laid down and buttoned up



there is storage room on top of the rack for more gear and equipment! Out on the trail it was a snap to pull our gear out of the wagon and use it on the trail maintenance project. Mike Dahlmeir and Jim Maxey removed rocks from a landslide on the trail #300 and filled in the edge of the trail with gear removed from the

trailer. It got pretty warm (85 degrees) and it was really nice to pull a bottle of ice water out of the trailer to quench our thirst! Pulling the trailer around sharp turns, through creek beds and along whoop de dos was no problem for Mikey. Most of the time he didn't even know the trailer was back there, thanks to the electric braking system and dual axels! Our hats go off to Bosski, Inc. and Snake River Yamaha for making life easier for us out on the trails we maintain. PROPOSED ADDITIONS TO BYLAWS—VOTE THIS MONTH

Having participated in two audits of the Boise Chapter Idaho ATV Association in the past three years, we thought it appropriate to make recommendations to improve the efficiency of the audit process and clarify certain activities of taking in and expending funds, recognizing the associations' right to purchase personal property and to create a mechanism for divesting itself of personal property which is no longer of use to the Association; recognize in Association Bylaws, the need for sound practices in taking in and expending funds, and the records keeping thereof, and the appropriateness of an annual audit.

We think it important that members understand that this report and the accompanying recommendations is in no way meant to cast an impression of past inappropriate activities. It should be taken as a compliment to previous and current Association leadership to have foresight to see the benefit of improving its system of accounting for Association assets.

Therefore, the 2010 Audit Review Committee recommends that the following be discussed and debated at a full meeting of the Boise Chapter of the Idaho ATV Association membership at its regular monthly meeting and that from these discussions a proposal made to amend Association Bylaws.

(First) That the Treasurer of the Association be compelled to use an automated bookkeeping system sufficiently sophisticated to handle recording business transactions and produce such reports as may be appropriate to demonstrate taking in and expending association funds upon demand. Such system may be upgraded from time to time as technology and efficiency demand.

(Second) That the Boise Chapter of the Idaho ATV Association declare that its fiscal year begin April 1, of each calendar year and end March 31, of each calendar year.

(Third) That Association leadership including all elected officers and such other members as be needed, prepare a budget for the new budget year listing individual line items and amounts proposed to be spent within each. Such budget then be presented to the general membership for discussion and approval at the regular March meeting.

(Fourth) That at each regular meeting of the Association a brief report from the Association Treasurer be presented to the membership which generally describes monies taken in and moneys expended (and the reasons therefore) and concluding with an ending balance and noting that the balance is in line with its annual budget.

(Fifth) That the Treasurer have March 31 to May 15 of the fiscal year to complete his or her bookkeeping duties with respects to the previous year financial activities to close the books and submit them to the Audit Committee.

(Sixth) That on or about May 15, of each fiscal year, an audit committee made up of qualified members of the Association, be presented records of the previous years' financial records for examination. Those records should include: a) a current copy of Association Bylaws, b) bank statements for the previous fiscal year, c) all records authorizing expenditure of Association funds, d) receipts of all expenditures, e) receipts of all funds taken in by the Association, f) copies of checks provided from Association banking institution, g) a full current inventory of all personal property owned by the Association, h) At the time of the annual inventory or when it comes to the attention of the Treasurer that a particular asset is no longer of use to the Association, the Treasurer and one other Officer of the Association shall inspect the item at issue and collectively determine that: a) the item is no longer of value to the Association, b) determine an approximate value and, c) the item should be disposed of as provided by Association Bylaw. The Treasurer shall make note of this activity for records keeping purposes. A list and value of all property disposed of during the fiscal year just ended along with an explanation of why it was disposed of, its listed value, when it was disposed of and who received the items, on all items valued at less than \$100.00. Along with original copies of receipts showing such transfer, i) any other record not specifically listed before, that records taking in or expending Association funds, adjustments to Association fund balances, acquisition of personal property or no longer in the possession of or owned by the Association, j) all records except for cancelled checks should be original copies.

(Seventh) That the Audit Committee be made of members of the Boise Chapter Idaho ATV Association appointed by the Executive Committee. Aside from duties listed above, the Audit Committee may be tasked with completing a physical inventory of Association assets.

(Eighth) That the Audit Committee appointed by Association President and Executive Committee, be authorized to meet, review documents referenced above, meet with such Association Officers as need be to satisfy themselves that all funds and personal property taken in and/or disposed of by the Association during the previous fiscal year meet standards set by Association Bylaws, that all funds have been accounted for appropriately. That upon completing examination of records and meeting with Association Officers, the Audit Committee report its findings along with any recommendations, to The President of the Boise Chapter of the Idaho ATV Association and the general membership at the regular meeting of the Association no later than March of the new fiscal year.

PROPOSED ADDITIONS TO BYLAWS—VOTE THIS MONTH

--- CONTINUED FROM PREVIOUS PAGE ---

(Ninth) That it be the policy of the Boise Chapter Idaho ATV Association to require approval by a quorum of those present at any regular meeting of the expenditure of funds exceeding Three Hundred Dollars (\$300.00) to any one vender for any one item prior to that item being purchased or ordered for delivery. That expenditure of funds less than Three Hundred Dollars may be authorized by a vote by a quorum of Association Executive Committee members prior to such expenditure. If such individual expenditure is to be of an ongoing nature, it must be approved by the general membership of the Association at any regular meeting prior to committing to such an agreement. The Treasurer shall review continuing contracts such as subscriptions, membership in other organizations, insurance policies, and other such agreements of a continuing nature which have a financial impact upon the Association and offer advice to other Association Officers regarding the efficacy of continuing to support such agreement. Timing of such review shall be determined by the Treasurer to coincide with the Association budgeting process, or upon expiration of membership. Association Directors and officers will determine by vote to either continue or discontinue the relationship.

(Tenth) Upon receipt of Audit Committee finding each fiscal year, the Executive Committee may determine the appropriateness of disposing of "surplus" property of the Association. The term "surplus property" shall be defined as personal property that is no longer needed or useable or useful to the Association. A list of such property to be disposed of is to be compiled noting the general condition and a value based upon the age condition and general usefulness of the item. Items should be listed and described by category. Individual items may be given to groups. Items may be sold. Items may be given to charitable organizations. Items should be given to Association members only if all of the membership is provided an opportunity to participate in acquiring those items.
