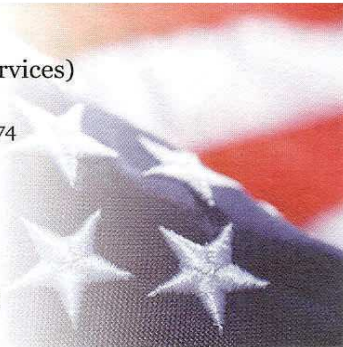

Trail Difficulty Guide

- ☉ **EASY** — Mostly flat trails/roads with gradual hills, no side hills, some water crossings less than 10 inches in depth, and possible mud depending on season.
- ☐ **INTERMEDIATE** — Some side hills, loose rocks, water crossings between 10 to 16 inches in depth, possible muddy and ruddy trails/roads, and occasional steep hills, and possible some snow and/or ice depending on the season.
- ◆ **DIFFICULT** — Possible rocky or deep ruddy trails/roads and steep side hills, potential water crossings with depth over 16 inches, very slow travel and possible deep snow and/or ice depending on the season.
- ☉ **COMBINATION** — Combination of difficulties or variety of terrain (Intermediate to Difficult).
- ? **NOT KNOWN** — No information at publishing time.

Note: The conditions of the trails or roads are subject to time of year and weather.

BE AWARE OF NOXIOUS WEED DANGERS

Memorial Day weekend traditionally marks the start of Idaho's recreational season. But state noxious weed officials say it is also the start of the state's greatest period of threat from the spread of noxious weeds. That means Idahoans headed out to recreate need to exercise special care in helping to prevent new noxious weed infestations from gaining footholds in the state's great outdoors.

"Idahoans will be boating, hiking, camping and participating in other recreational outdoor activities, all of which can unknowingly spread noxious weeds. The best way to control these invasive weeds from spreading is to stop them from hitching rides on boats, trailers, RVs, bikes, camping equipment, ATV's even your clothing or animals," said Roger Batt, Idaho Weed Awareness Campaign coordinator.

Invasive weeds pose a serious threat to Idaho's economy, ecology and agriculture, causing an estimated \$300 million annually in damages. The state annually spend upwards of \$20 million to combat noxious weeds but still loses control of hundreds of acres of land

every day to 57 varieties of noxious weeds known to have infested the state. Batt said there are several tips recreationalists can follow to help control noxious weeds.

- ◆ Learn to identify plants common to your favorite recreation areas, so you can recognize potential invaders and report them to land and wildlife managers or your County Weed Superintendent located under County Government in the phonebook.
- ◆ Avoid traveling through weed-infested areas with ATV's and other off-road vehicles. Driving through infested areas can pick up and distribute weeds and weed seed.
- ◆ Only set up camp in weed-free areas.
- ◆ Don't pick or transport "pretty wildflowers" you can't identify – they may be noxious weeds whose seeds you are inadvertently spreading to new locations.

- ◆ Check boats, trailers, and watercraft carefully after they are pulled from the water for signs of aquatic weeds such as Eurasian watermilfoil.

"Some of Idaho's worst noxious weeds disguise themselves as pretty wild flowers. That's why it is crucial that Idahoans know how to spot a noxious weed and to tell it apart from native vegetation so we can stay ahead of the spread of noxious weeds," Batt added.

Idahoans are urged to get their own copy of the Campaign's free Idaho Noxious Weed Guidebook. The detail-packed, 115-page book has color photos of Idaho's 57 noxious weeds, plus detailed information about how to identify the different species of noxious weeds. SHARING OUR TRAILS: A GUIDE TO TRAIL ETIQUETTE

In many areas where we recreate, trails are open to and shared by equestrians, OHV riders, bicycle riders, runners and hikers. Trail sharing can and does work when people respect each other and work cooperatively to keep each other safe.

While it is important for people to respect each other on the trail, it is important to remember that equestrians are dealing not only with other trail enthusiasts' personalities, they also are working with horses whose temperaments are as individual as our own. Horses' natural instincts can influence their behaviors and affect the way they react to circumstances encountered on the trail.

Rules of Common Courtesy:

- ♦ Respect all trail restrictions and use only trails open to your mode of transportation.
- ♦ Be considerate of others on the

road or trail.

- ♦ When traveling on shared-use trails, continually watch for other types of recreationists.
- ♦ Slow down when sight lines are poor.
- ♦ Keep speeds low around other recreationists.
- ♦ Keep noise and dust down.
- ♦ Keep your ears open – no ear buds for an MP3. Listening to headphones or ear buds can make it difficult to hear and communicate with other recreationists. In some areas, it is illegal to operate vehicles or bikes with both ears covered.
- ♦ Keep pets under control. Some trails require dogs to be

leashed.

- ♦ Be familiar with local rules.



Rules of Yielding:

- ♦ Yield the right of way to those passing you from behind or traveling uphill.
- ♦ Motorized vehicles yield to mountain bikes, runners, hikers, and horses.
- ♦ Mountain bikes yield to runners, hikers and horses.
- ♦ Runners and hikers yield to horses.

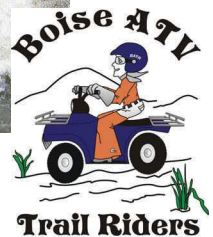
MURPHY AREA—EARTH DAY CLEANUP

From April 23 through April 25, the Kuna Trail Riders sponsored an Earth Day Clean Up Project just south of Murphy, Idaho on land managed by the BLM and owned by the Joyce Ranch. Over sixty members of the Kuna Trail Riders, the Boise ATV Trail Riders, the Canyon County ATV Club, the Emmett ATV Rough Riders and the Mountain Home ATV Club showed up for the project and spent three days cleaning up trails in the area, maintaining area trails and getting to know each other better. Doug Mason from the Boise ATV Trail Riders and Washington from the Mountain Home ATV Club had a most wonderful time hauling garbage and debris away from the Montini Cabin. After they

carted away the trash from around the cabin, other club members gave the cabin a thorough cleaning inside and stocked it with non perishable provisions.
