MEETING MINUTES FOR FEBRUARY 20, 2018

I read the minutes from the January meeting. Dennis Colton motioned to accept, Patrick Sherman seconded.

Chris gave the treasurer's report. He stated that we had received deposits of \$1,289.44 leaving a balance in our account of \$1,452.80. Linda Colton motioned to accept, and Patrick Sherman seconded.

John didn't have anything to report for the club store.

There was no unfinished business.

We discussed the BLM public comment meetings on Feb 27th at the Nampa Civic Center and the 28th at the Murphy museum. It was asked that everyone that could attend to please do so. It was mentioned that Ranchers are not worried about the clubs because clubs are only riding on existing trails, not creating new ones like the random rouge riders are. It was mentioned that at the meeting you will need to take a marker & mark maps on trails we want to keep open. So study your maps so you are prepared.

Jim Maxey gave the Tales from the Trails. Steve discussed his recent crash and the importance of a good helmet.

Jim Maxey also stated that all the volunteers for the Sportsman Show had been assigned.

He mentioned to keep an eye on the website. On March 18th Magic Valley club is tentatively scheduling a ride to Bruneau.

May 25-28th is the Hells Canyon Ride. It is \$137 per person which gives you insurance for 2 rides, a steak dinner and a t-shirt.

Kilgore has added rides this year; July 14-15 to Cold Springs Lookout. Watch for these on the website.

We had a guest speaker, Paulie Buzzini from Life Flight. She stated that a Life Flight membership is covered anywhere in the Northwest. Renewal notices are mailed every year and there are no discounts offered online. Also the new discounted price for the club is \$50 from \$45.

Dennis Colton motioned to adjourn and Patrick Sherman seconded.

We had a clinic on first aid that was presented by Bob Shumaker.

MEETING MINUTES FOR 3/20/18

I read the minutes for the February meeting. Kris Wainwright motioned to accept and Walt seconded.

She stated that the IRC is there for us as recreationists to use to protect our trails. Membership is free and everyone is welcome.

Sandra stated that if you want to be alerted to news to go to the website (IRC.org) and click on the Public Lands Alert button, or to simply send her your email address and she would email you on things of interest. She will also give you suggested comments on the upcoming election in 2018 and give links to legislators.

New business: Kris Wainwright mentioned that the UTV Invasion ride opens up for registration on April 1st and for everyone who is interested to watch Meetup as it fills up fast...

Steve discussed trails that are currently closed in the Boise National Forest.

Steve reminded all the board members that the next board meeting will be April 12th.

Jim Maxey gave the Tales from the Trails. Mentioned that ATV/UTV safety classes for 2018 are scheduled at Pickles Butte and Idaho Parks & Rec.

He presented Steve with the Crash Dummy trophy for Steve's outstanding crash on Feb 17th.

Jim also stated that the Sportsman's Show was a huge success. That all the volunteers showed up when they were supposed to and that they saw a lot of traffic all 4 days.

Steve made a motion to adjourn. Reed Coleman motioned and Wes Bender seconded.

The clinic was postponed until next meeting.

4-17-18 MEETING MINUTES

I read the minutes from the March meeting. Bill Jones motioned to accept and Rick Borders seconded.

Kris Wainwright stated that the minutes from the board meetings would be posted on the website as soon as he made a few more changes. He also mentioned that if anyone was still having problems with meetup, to stop by his table as he brought his tablet and could get them fixed.

John Turpin mentioned that he was going to be placing an order for t-shirts and sweatshirts and for those people who wanted them to stop by his table and fill out an order form.

Unfinished business – Steve stated that we have 88 people that have not renewed their membership for 2018, and that if they hadn't paid by the end of the month that we would be removing them from the website.

New business – Rick and Roberta from the Canyon County club talked to us about their Poker Fun Run & campout on June 22nd and 23rd. Since it is a "poker run" they cannot charge for it because then it is gambling so it will be free. The ride will be at Chalky Butte which is about 2 miles past Hemingway Butte. There will be a 65 mile self-guided ride that is accessible to all machines and is moderate/intermediate, and also a 32 mile easy ride for beginners. Birds of Prey will be their sponsor again and will be bringing out demo machines. They will be offering a \$100 purse for high & low hands. Hal Hunt will be offering a dutch oven dinner (as long as there is not a burn ban). For those that want to camp they are asked to come early as there is not a lot of room for campers and it will be a first come first serve basis. Jim Maxey will be doing the parking. Registration will begin at 8 and the rides will start between 9 & 10. For those that are camping, there will be pastries, coffee & orange juice offered on Sunday morning as well as a 50 mile guided ride to probably Diamond Basin. The course will be well marked with ribbons.

Mike Pierce said that the Idaho City Snowmobile Club wanted to do a fun run this past winter but was unable to due to not enough snow so now they want to do a fun run this summer. The ride will be open to ATV's and side by side's and will be on June 16th in Idaho City. They will be using the same route that they would have on the snowmobiles departing from Granite Creek parking lot. Check-in is from 9-11 am with a \$5.00 entry fee. After the ride they will be meeting at Robinson Hall in Idaho City for a raffle. 1st prize will be \$400, 2nd prize \$300 and 3rd prize \$200. Camping is possible but there is not a lot of it. He will update us next month.

Bill Jones stated that he would be offering a GPS class on Wednesday, May 2nd at 5:00 pm at Pleasant Valley and power line for those that are interested. You are asked to bring fresh batteries for your GPS, your instruction manual and your ATV. To get there, you head south on Pleasant Valley Road past the penitentiary, past Kuna Mora road, past the railroad tracks until you get to the powerlines.

Sandra Newton gave the Tales from the Trail report. She also talked about a few suggestions for this years Xmas party and passed around 2 get well cards for Tom Zumwalt for people to sign.

Jim Maxey clarified that in Oregon for the safety sticker, that only Class 1 (ATV's) and Class 3 (motorcycles) had to take the safety class in Oregon. Side by side's are not required by law to take it as they are a Class 4.

All the rides are posted on the ride center and he stated that you need to RSVP as some of the rides have limits. A couple of the rides have been split into two rides, due to the size of the groups so be sure and go onto the ride center and choose whichever day you want to ride.

Randy Johnson gave the membership report. We had one new member in December, one in January and another joined tonight. We had received 27 payments at our January meeting for membership. But membership is down, so we need to work on that.

It allows unlimited number of transports per year for anyone in the household. They are made up of a lot of volunteers, roughly 86% of the EMT's are volunteers. The average cost of a helicopter is \$60k and the average cost of a plane is \$48k per trip. She stated that if you are a member there is an iPhone app for Air St Luke's and she encouraged everyone to put that on their phones. If you received a renewal in the mail and it was for more than \$45, you need to call Lisa in their office and let her know you are associated with the Boise ATV club. Air St. Luke's reciprocates all air transport services, so if you are in an area where someone else needs to fly you out, it will be covered, as long as you are in one of the states listed above. You can call your own emergency in as well if you are able.

Sandra mentioned that she had sent out an email to all the inactive members reminding them about club dues and said that if anyone says anything to you to please tell them that we want them to re-join our club, but we had to stop people from using our ride center illegally.

Kris Wainwright then gave a demonstration of how Meetup works. He explained that you should have two sites on Meetup, one for the ride center and one for the Club Calendar. He said if you do not have both to see him and he would help you get both set up. He mentioned that if you want to update your profile, you will need to do it on a tablet or computer, it will not work on your phone.

Sandra asked for a motion to adjourn. Linda Colton motioned and I 2nd.

2/19/19 MONTHLY MEETING MINUTES

The 3rd bill is HB74 which will allow anyone to buy a sticker for a machine, not necessarily the owner, and will also allow us to purchase a 2-year sticker for \$22.50. This will be available in 2020. And the last bill is HB75 which will add a \$12 non-resident sticker fee has passed the house. He stated that they would vote on the senate floor on Thursday and requested everyone to send another email prior to Thursday. Monthly Meeting 5/18/21

We said hello to 3 guests and/or new members

I read the meeting minutes and Donna Weast motioned to accept, Kellie Flory 2nd.

Kellie Flory gave the treasurers report and state that our new balance was \$5,489.28. Steve Huffman motioned to accept and Donna West 2nd.

Randy Johnson was not present so Sandra gave the membership report. In May we have 3 new members and a total of 103 paid members.

Patrick was not present for the club store report. However, he has been working to the GOS programs for the club to download. There have been several that have downloaded the rides and signed the release form. You have to download Backcountry Navigator first in order to download these files.

The new logo T-shirts are now available on the club store to purchase. Last week we had 32 ordered so only 4 more need to be ordered to complete our minimum. Jim also brought hats for \$5. He sold out.

The ISATVA Annual Meeting is generally held once a year. However, due to COVID-19 it was cancelled for 2020. Rusty Faircloth has asked the BATVC to host in 2021 and we have accepted. Steve Huffman, Sandra Newton, Karen and Gary Duvall (Canyon County club) and Sheila Harris will be the panel arranging everything. The meeting will be held at Burgdorf Idaho on August 19 through the 22. Camping will be at Pete's creek. There will be 3 rides per day and 2 on Sunday. The group will be meeting on a regular basis. We are asking for volunteers to help with registration, set up, handing out packets, etc. We also need volunteers to go out and get donations.

No further business to discuss. Karla Cleveland motioned to adjourn and Kellie Flory 2nd.

Monthly Meeting 6/15/21

We welcomed 6 guests and/or new members.

Sandra gave the Tales from the Trails as Jim was out of town.

Sandra gave the Treasurer's report stating that we currently have \$6,073.18 in our account. We also opened a separate account for the ISATV and that it had a balance of \$1,311.29 in it.

Since May we have 6 new members and a total YTD of 110 paid members

Patrick will give us a presentation next month on the GPS program and how to download the maps and rides that he has been working so hard on.

We sold the first 36 t-shirts and opened up another round for people wanting to order.

David Claiborne with the ISATVA was our guest speaker. The state ATV association represents both ATV's and UTV's. They have 20 clubs and over 2500 members. Their main focus is on access issues, preserving trails, legislative issues and occasionally lawsuits. The 2 legislative bills this year were the Registration Modernization Bill. We now buy our stickers over the counter from a vendor instead of thru the DMV. They decided that the sticker did NOT have to be tied to the machine, because the goal was to sell stickers for money to preserve the trails. Right now, 60-70% of the monies is being spent on single track trails and roughly 80% of the monies are coming in from ATV/UTV's. So there is a problem. They have 3 crews working during the summer clearing single track trails. Starting next week, they have hired a fourth crew to work only on ATV/UTV trails. This crew will work year-round, so in the winter months they will work mostly on the Owyhee trails. The 2nd bill is the highway dues bill. Currently you can ride an ATV/UTV on highways within the city and 1 mile outside the city. Starting July 1, you can drive on all local roads, on a state highway where the speed is 60 miles per hour, you will be able to ride for up to 5 miles at a speed of no greater than 45 mph. You must have the black & white restricted license plate and sticker on your machine in order to do that. If you are from out of state, you can buy a plate thru the DMV. A question was asked if the BATVC could be a vendor in selling the stickers, and David stated that yes, we could. We just have to register at IDPR.

David then talked about the changes for the snowmobiles. They had a fee increase from \$32.50 to \$45.50 for resident and from \$32.50 to \$59.50 for non-residents. They have not had a fee increase since 2011 so they were due. This will bring in more monies for trail maintenance. Plus \$1 from every sticker sold will go to an Avalanche Fund and \$1 will go to recreation enhancement.

He then discussed the Wilke's brothers and what if anything was happening. We currently have 3 access agreements with them, New Meadows/McCall, Herrick Reservoir to East Mtn, and Boise Ridge Road. 2 years ago the Wilkes Brothers called the ISATVA and asked them to look at maps and go over everything to do it all in one fell swoop instead of piece-mealing it. Then the Idaho Statesman starting printing all these articles bashing them, and the dealings stopped. The ISATVA is hearing some grumblings that maybe they would like to resume this .

Someone asked how much money we are bringing in on fees and David didn't have the exact numbers with him, but he believes it is approximately \$142k, with roughly \$20-30k from non-resident. Then he

discussed what's happening up around McCall right now. Trident Holdings has sent a proposal to the State to trade them some prime timber land up north for the land around Payette Lake. This would increase the size of the park as well as building of affordable housing, schools, stores, etc. All motorized trails would remain open. There are other offers out there as well, but this one looked the most lucrative. The state has until July to make their decision.

Sandra then stated that the ISATV Annual meeting was proceeding nicely. She has acquired the caterers, tables and chairs, sponsors, raffle items, etc. Registration will remain open until July 30. Someone mentioned that we should invite the forest ranger supervisor to come and talk to us and go on a ride with us. Sandra said that she would definitely do that. Sandra also stated that she asked the board for \$400 to go towards whatever expenses may come up. They agreed.

Sandra then stated that our meeting next month would be back at Idaho Pizza in Meridian.

No further business to discuss so meeting was adjourned. Wes Bender motioned and Linda Coltrin 2nd.

Monthly Meeting 9/21/21

We started off the meeting welcoming 6 new guests

Jim gave the Tails from the Trails report. He also presented Kellie Flory with the crash trophy.

As I was not present at the July meeting, there was no Secretary's report

Kellie Flory gave the treasurer's report. She stated that as of 7/20 we had a balance of \$5,542.53. After all deposits and payouts we have a new balance of \$5,802.83. In our ISATVA account we have a balance of \$2,467.88. Bruce Fuller made a motion to accept and Wes Bender seconded.

Bob Shumaker stated that we have 124 paid members as of 10/19. Reminded everyone that dues are due by December 31.
