JANUARY 24, 2023 GENERAL MEETING MINUTES

Kelly Dwello, Election Chairman, opened the January 24, 2023 meeting of the Boise ATV/UTV Trail Riders at 7:00 PM at Idaho Pizza in Meridian, Idaho. Kelly welcomed all members and guests. The Pledge of Allegiance was recited. Kelly introduced Jim Maxey who was the Master of Ceremonies for Installation ceremony. Kelly gave a brief bio of Jim and Jim then reviewed the club mission and vision.

David Clayborne, State ATV Association President, recognized the importance of the Boise ATV/UTV Trail Riders club and gave a bit of history from original organization to merger into state organization. David thanked the Trail Riders not only for the club's support for the State organization but also the great history of good leaders in this club. Legislature issues will be discussed another time.

Jim Maxey shared a few ideas on the importance of our club – convenient location for riding, good ride leaders, Sportsman Expo show, help with trail cleanup, campouts, summer picnic and the Christmas party.

Formal installation ceremonies began with Jim recognizing outgoing directors and officers and then introducing new directors and officers. A bio on each director and officer was given. The charge of duties and responsibilities of positions was given not only to the new directors and officers but also to members of club. Gavel was exchanged and the presentation of new board was officially announced.

Patrick thanked Jim and Kelly for helping with installation ceremony. Going forward, Patrick hopes this installation will set a precedent and this club will become the premier club in state.

Patty read minutes from the November 15, 2022, general meeting. Minutes were approved as read.

Kelly Flory gave treasurer's report. Balance on 12/15/22 was \$6798.00. Deposits made were \$650.32 and expenses were \$5485.31 leaving ending balance as \$1963.01. Report accepted as read.

Kelly Dwello report 2023 membership as of today at 78, 66 renewals and 12 new members. He again encouraged members to use web site for renewals as much easier for the accounting. Kelly also reiterated that a new application for renewals must be completed each year which provides updated member info as well as a liability release.

As Sherri Thurston is out of town, Patrick reported on Christmas party. Patrick and several members in attendance agreed Eagle Hills was a good venue for the party. Ronald McDonald House sent a thank you showing their appreciation for the club's contributions.

Under unfinished business, Patrick reported he had 18 calendars to sell for \$15 each. Calendars were made from Shutterbug pictures and winners at Christmas party. Also several left-over shot glasses from the Christmas party were offered free for the taking.

Patrick also displayed a slide showing his agenda for the upcoming year. In addition, he showed slides from several years ago representing members' preferences on ideal group size for rides and distance for rides. At this meeting, the majority preferred (by show of hands) ride size of 10-20 and 50-70 miles on the ride. Patrick indicated it is a challenge to keep rides small. He gave his e-mail address and asked members to send their ideas on how to accomplish this and he will report info back at next meeting.

Patrick reported the Board has and is reviewing some of the following items: how to get members engaged in the club, how to transition from year to year, how to reduce ride size, the budget, and a by-law review.

Another item presented by Patrick was having a new member cocktail party every quarter as an opportunity to get acquainted. He also introduced Roxie wearing her "Expect Self Rescue as No One Is Coming" t-shirt and the Jimmy 6 challenging trail rides. T-shirt to be awarded at year end to member who completes all 6 rides. Also introduced was the Trailmaster Award for attending in one year 50+ events offered by the club. Person who accomplishes this will be presented with a trophy and dinner. Also at 2023 Christmas Party, a best Shutterbug Award will be given.

Jim Maxey reported the Meridian Christmas night ride had 6 well decorated machines, 11 riders and 5 volunteers. Again for the 4th year, this group took 1st place in the motorized category. Jim reviewed past rides and recommended checking website for future rides. Jim reminded members to contact Oregon State Parks and Rec to purchase the 2 year off-road sticker for \$10.00. Also the Oregon ATV safety course is online. Also, if riding in Utah, check online for current requirements. Some confused discussion was shared on renewing Idaho license plate but registration sticker for 2023 is \$12.00 from Idaho Parks and Rec.

Patrick presented recognition awards to Jim Maxey for Ride leader, Picnic coordinator and Sportsman Show coordinator and to Randy Johnson for membership coordinator and Board Director. Bill McBroom was presented a past president plaque.

New members Larry and Helga Kerbs were introduced and participated in the new member orientation.

Minutes for the ATV/UTV General Meeting

February 21, 2023

William Cawthorne opened the February 21, 2023 meeting of the Boise ATV/UTV Trail Riders at 7:00 PM at Idaho Pizza in Meridian, Idaho. The Pledge of Allegiance was recited.

William introduced himself as new President of club as Patrick Sherman resigned. Dale Boatman was introduced as new Vice President. These decisions were made at the February 16, 2023 Board meeting.

Secretary read the January 24, 2023 general club meeting minutes and they were approved as read.

Kellie Flory gave the Treasurer's report. Beginning balance was \$1797.01 with deposits of \$128.22 and expenses of \$1404.60 leaving a balance of \$3073.39 on February 16, 2023. Treasurer's report accepted. Kellie presented the Board approved 2023 budget to the club membership for their discussion and final approval. It was explained that these are estimated figures for revenues and the expenses were based on last year's costs. Bill Davis made motion to accept budget, Paul Bonn seconded, and motion passed to accept 2023 budget as presented.

Membership report was given by Kelly Dwello. Current membership is 94 total, 84 renewals and 12 new members. Membership is a bit behind previous year's number. Kelly explained how to renew online and reminded members that he and a representative from Canyon County will soon begin purging unpaid members from Meetup. Kelly also reminded members to carefully review their profile information, so proper data is entered into Meetup.

New members introduced and welcomed into club: Andrew and Karen Sales and Cory and Alex High.

Bill McBroom was not in attendance for sponsors report, but Treasurer reported she had received sponsor payment from Birds of Prey.

Jim Maxey reported Sportsman's Show is March 2-5, Thursday thru Sunday. Several members volunteered to help setup, take down and participate in shift times. Jim announced to club that after 15 years as coordinator of Sportsman's Show he is stepping down after this year and giving someone else the opportunity to take over this project.

Jim also reminded members that club shirts can be ordered online from T-Zers. There are now 8 choices of shirts. Jim also has \$5.00 hats for sale.

Dale Boatman gave a brief discussion on programing radios and free radio training which is available on rideatvs.org.

Disabled Veterans' ride is August 26, but Steve Huffman was not in attendance to discuss more details.

Caleb Flory announced he would be leading the meeting as the Interim Administration as both William Cawthorne, President, and Dale Boatman, Vice-President, resigned. Caleb asked for members to volunteer for these positions. He also will be sending email to club members requesting membership to step up and help fill these vacancies. Any and all volunteers for these President and Vice President positions will be reviewed and announcements will be made at April Meeting.

Steve Huffman gave a brief report on August Veteran's Ride. Steve contacts the VA and they match up members for the ride. Not sure where ride will be but perhaps Fall Creek. Check the web site for more information and also to volunteer.

Patty read the February 21 meeting minutes and they were approved as read.

Kellie Flory gave treasurer's report, beginning balance on February 16 was \$3073.39 less expenses of \$ 227.55 plus income of \$1531.00 leaving balance of \$4376.84. Treasurer's reported accepted as given.

Membership report was given by Kelly Dwello. Currently have 133 members with 18 new members this month. Boise, Canyon County and Kuna are all working on removing unpaid members from roster. Boise Club had over 600 members and are now at 133. Several new members were in attendance. They were reminded that Life Flight or St Luke's Air membership is crucial.

Caleb reminded the membership to contact businesses they think might like to sponsor our ATV club and bring them on board.

Jim Maxey reported the Sportsman Show was successful and he had 14 good volunteers.

May 16, 2023

Caleb Flory, administrator of the Boise ATV/UTV Trail Riders, welcomed the club members at 7:00 PM at the Idaho Pizza in Meridian, Idaho. The Pledge of Allegiance was recited.

Patty Davis read the April 18 general meeting minutes and they were approved as read.

Kelly Flory presented the treasurer's report – balance on April 13 was \$4648.48, income from membership \$386.04 and sale of caps \$120.00 for total income of \$506.04 – expenses of \$36.04 for satellite phone, \$79.50 for summer picnic shelter, \$234.77 to Patrick Sherman for Sportsman's Show, \$114.50 to Jim Maxey for Sportsman's Show, \$100.00 to Jim Maxey for caps, \$200.00 for Bollinger benefit and \$50.00 refund for duplicate member payment for total expenses of \$814.81 leaving balance on May 16 of \$4339.71. Treasurer's report accepted as given.

Kelly Dwello, Membership Coordinator, was not at the meeting so Caleb reported the current membership at 155 including one renewal at tonight's meeting.

Tales of Trails report was given by Jim Maxey. As always, he had great past ride info, as well as reminders of the upcoming rides which are posted on Ride Center. Still snow on some trails creating detours or cancellations but other rides proceeded as scheduled and were good.

Jim also reminded members to be certain to get an Oregon permit before riding in Oregon – a \$10.00 permit as opposed to a \$350 fine.

Caleb shared with membership that 4 new shirt colors are now available on club store site. T-Zers needs quantity of four shirts before printing and then takes about 2 weeks for delivery.

Caleb also shared a QR code for a government website with a BLM project list for entire United States. The comment period ends June 20 so short span to read a 22 page report.

Speaker for the evening was Michael Lindenfelser, Southern Region Trail Specialist for Idaho Parks and Rec. He reported his trail crews are working in the Danskins, then Sagehen area and are resigning trails in Owyhee's. Snow has been a challenging issue this year in maintaining trails. Mike also mentioned there are trail contracts available for club participation with reimbursement to club with proper project documentation. If club chooses to organize a committee with chairman, Mike will give assistance to this committee.

Mike also presented the Owyhee cattle guard project. He gave general information, and a committee will be organized to follow up with Mike to proceed with the project. Bill Jones, a member of the club, briefly spoke about Paul Nettleton's issue with his gates being left open by ATV/UTV rides. Parks and Rec is aware of Mr. Nettleton's concern and has been in contact with him regarding this installation of cattle guards.

Terry Harvey was presented the Crash Award by Jim Maxey for his recent flip-over on a ride. Not seriously hurt, only bruises.

Jim mentioned the Meridian City Night Parade on December 1 as he needs to register if any members plan to participate. Several people said they would attend so Jim will register club. Also, the city would like volunteers for road guards starting about 3:00 if anyone interested.

November 18 is the ride leaders' meeting where about 15 people gather and decide on all club rides for the coming year.
